

Improving Mental Health and Psychosocial Support (MHPSS) for Conflict Affected Populations in Eastern Ukraine through Increased Capacity for Psychosocial Support Activities and Services Aligned with IASC Guidelines among National actors, Organizations and Agencies

WHO WE ARE

International Medical Corps (IMC) is a global, humanitarian, nonprofit organization dedicated to saving lives and relieving suffering through health care training relief and development programs. Established in 1984 by volunteer doctors and nurses, International Medical Corps is a private, voluntary, non-political, non-sectarian organization. IMC Ukraine has been implementing JSI/USAID and OFDA funded projects focused on mental health and psychosocial support (MHPSS) since 2015.

PROJECT BACKGROUND AND GOALS

Through the project "Improving MHPSS for Conflict Affected Populations in Eastern Ukraine through Increased Capacity for Psychosocial Support Activities and Services Aligned with IASC Guidelines among National actors, Organizations and Agencies" (2015-2017), which is supported by USAID and John Snow International, International Medical Corps seeks to achieve the following:

Objective 1: Strengthen the provision of mental health and psychosocial support in Ukraine in line with international principles such as the IASC Guidelines for MHPSS in Emergencies. IMC takes a lead role by

facilitating a Task Force comprised of government ministries, educational institutions, NGO and INGO representatives to operationalize and contextualize global best practices outlined in the the IASC Guidelines for MHPSS in Emergencies to Ukraine. To help coordinate MHPSS in Ukraine, IMC also leads the MHPSS sub cluster coordination group. IMC is also translating and disseminating best practice guidelines and the following publications which are available:

- IASC Guidelines for MHPSS in Emergency Settings (Russian and Ukrainian)
- IASC Guidelines for MHPSS in Emergency Settings Checklist (Russian and Ukrainian)




Objective 2: Strengthen the capacity of relevant local organizations to apply IASC Guidelines through capacity

building and training. IMC is building the capacity of 5 local partner organisations to facilitate appropriate psychosocial support activities for affected communities in line with the IASC Guidelines. Partners include:

- A local media organisation to create radio programmes designed to reduce stigma and negative preconceptions around mental health in the country.
- A local university to train social workers and volunteers in ways to enhance psychological resilience as part of their education and practice.
- Three community based organizations who provide community based psychosocial support to conflict affected populations including war veterans and their family members, internally displaced persons and host communities.





Objective 3: Strengthen capacity to link psychosocial support to evidence-based mental health services for conflictaffected populations in at least one city in Eastern Ukraine.

- In line with the IASC Referral Guidance Note for MHPSS and the IASC 4Ws (Who is doing What, Where and until When) Activity Codes, IMC completed and disseminated a service mapping in Zapporigia and continues to support coordination meetings to further strengthen referral pathways.
- IMC is also mapping services and strengthening referral pathways in Kramatorsk, Bahkmut and Durshivka.

Upcoming Events:

IASC Training of Trainers: The IASC ToT is targeted towards persons involved in MHPSS service design and delivery in Ukraine. The IASC ToT will equip and support

Ukrainian Focal Points in their role to know the IASC Guidelines, advocate for use of the IASC Guidelines, help disseminate the IASC Guidelines and institutionalize the IASC Guidelines in their own organizations and agencies.

National Conference: The National Conference planned for June 14th and 15th 2017 in Kiev seeks to share results of using the IASC MHPSS Guidelines in Ukraine, disseminate finalized materials, and support an agenda for continued development of integrated MHPSS system in Ukraine.
